SUMMARY ANNUAL REPORT **Puget Sound Electrical Workers Healthcare Trust**

FOR THE YEAR ENDING
July 31, 2018

This is a summary of the annual report of the Puget Sound Electrical Workers Healthcare Trust, EIN 91-6029124, Plan No. 501, for the year ended July 31, 2018. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Trustees of Puget Sound Electrical Workers Healthcare Trust has committed itself to pay certain medical, life, dental, vision, disability and prescription drug benefits incurred under the terms of the plan.

Insurance Information

The plan has contracts with Lifemap Assurance Company and American Alternative Insurance Corporation to pay certain medical, life, temporary disability, and accidental death and dismemberment benefit claims incurred under the terms of the plan. The total premiums paid for the plan year ending July 31, 2018 were \$2,236,363.

Because the contract with Lifemap Assurance Company is an “experience-rated” contract, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending July 31, 2018, the premiums paid under such experience-rated contract were \$425,008 and the total of all benefit claims paid under the experience-rated contract during the plan year was \$347,500.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$50,950,308 as of July 31, 2018, compared to \$46,228,069 as of August 1, 2017. During the plan year the plan experienced an increase in its net assets of \$4,722,239. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan’s assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$106,503,352, including employer contributions of \$98,181,546, employee contributions of \$5,522,054, realized losses of \$119,233 from the sale of assets, earnings from investments of \$1,722,529 and other income of \$1,196,456.

Plan expenses were \$101,781,113. These expenses included \$5,104,008 in administrative expenses, and \$96,677,105 in benefits paid to participants and beneficiaries.

2. Financial information and information on payments to service providers;
3. Assets held for investment;
4. Transactions in excess of 5% of plan assets; and
5. Insurance information including sales commissions paid by insurance carriers.

You also have the right to receive from the plan administrator, on request and at no charge, a statement of the assets and liabilities of the plan and accompanying notes, or a statement of income and expenses of the plan and accompanying notes, or both. If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan at 7525 SE 24th Street, Suite 200, Mercer Island, WA 98040, and at the U.S. Department of Labor in Washington, DC or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
