SUMMARY ANNUAL REPORT FOR PUGET SOUND ELECTRICAL WORKERS 401(k) SAVINGS PLAN

This is a summary of the annual report for the Puget Sound Electrical Workers 401(k) Savings Plan, EIN 91-6180326, Plan No. 001, for the year ended May 31, 2021. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by the Trust. Plan expenses were \$25,139,159. These expenses included \$1,136,115 in administrative expenses and \$24,003,044 in benefits paid to participants and beneficiaries. Administrative expenses include administration fees, investment fees, auditing fees, attorney fees, banking fees, consulting fees and miscellaneous expenses. A total of 7,742 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$450,391,960 as of May 31, 2021, compared to \$336,928,241 as of June 1, 2020. During the plan year, the plan experienced an increase in its net assets of \$113,463,719. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$138,602,878, including employer contributions of \$19,234,515, participant contributions of \$11,826,232, other contributions of \$372,958, earnings from investments of \$107,165,398 and other income of \$3,775.
