SUMMARY ANNUAL REPORT FOR PUGET SOUND ELECTRICAL WORKERS HEALTHCARE TRUST

This is a summary of the annual report for the Puget Sound Electrical Workers Healthcare Trust, EIN 91-9029124, Plan No. 501, for period August 01, 2023 through July 31, 2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has contracts with LifeMap Assurance Company and Sun Life Assurance Company of Canada to pay life, accidental death and dismemberment, and stop-loss claims incurred under the terms of the Plan. The total premiums paid for the plan year ending July 31, 2024 were \$1,425,814.

Basic Financial Statement

Benefits under the plan are provided by the Trust. Plan expenses were \$142,277,520. These expenses included \$7,022,275 in administrative expenses and \$135,255,245 in benefits paid to participants and beneficiaries. A total of 6,590 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$34,789,381 as of July 31, 2024, compared to \$53,708,355 as of July 31, 2023. During the plan year the plan experienced a decrease in its net assets of (\$18,909,974). This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year. The plan had total income of \$123,367,546, including employer contributions of \$113,139,099, employee contributions of \$5,439,640, gain of \$277,414 from the sale of assets, net investment gain of \$4,759,358, and other income of \$29,449.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

Additional Explanation

To comply with the Department of Labor instructions, the plan's obligation for accumulated eligibility credits of \$36,738,000 as of July 31, 2024 and \$42,651,000 as of July 31, 2023 have not been included in the Form 5500 and have not been included in this Summary Annual Report. The exclusion of the accumulated eligibility credits obligation decreased net assets, reflected in this Summary Annual Report, at July 31, 2024 by \$36,738,000 and \$42,651,000 at July 31, 2023 and increased the benefits paid to participants and beneficiaries, reflected in this Summary Annual Report, by \$5,913,000.
